* STUDENT TUITION RECOVERY FUND:

The state of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition. You are not eligible for protection from the STRF, and you are not required to pay the STRF assessment if you are not a California resident or are not enrolled in a residency program.

The Student Tuition Refund Assessment rate for the enrollment agreements signed after February 7, 2021, is \$2.50 per \$1,000.00 of institutional charges **rounded to the nearest thousand dollars** from each student. The STRF assessment is non-refundable. The school is instructed to collect the assessment from an enrolled student at the time of the first payment for the **entire sum of the program cost** regardless of whether the student pays the charges in increments or in full. **(Please note: The Student Tuition Recovery Fund is non-refundable).**

**The State of California requires that all persons performing radiographic procedures on human beings holds a current California State license. The school has included the fee for the x-ray exam into the program's tuition. The student must return all extern documents to the school:

- no more than 30 days after completion of the last logged x-ray exam and
- no more than 10 days after receiving the acceptance letter from ARRT (American Registry of Radiologic Technologists).

Medical Assistants working in the State of California are not required to be certified to obtain employment, although more and more medical facilities are adopting the policy of hiring only Certified Medical Assistants, therefore MCCNC recommends that our graduates get their medical assisting certification. For that purpose, the school has included the cost of the medical assisting certification into the cost of the program. The student must return all extern documents to the school:

- no more than 30 days after the completion of the 160 hours of medical assisting externship.

*** The Program Total includes the total charges for the entire educational program

**** The last day of attendance is defined as the last day a student had academically related activity.
